This process begins with a root cause analysis that identifies underlying problems that represent a risk of future incidents. The following example is a corrective action plan produced in response to an outage of a software platform.

Sample Letter of Reprimand for a Manager. This employee reprimand is issued to a manager. It is a serious, ethical breach for a manager to overlook employee confidentiality. Managers are held to a higher standard than this manager exhibited. A letter of reprimand to a manager is a rare event.

This could play a significant factor should litigation arise from a later employment termination. It also provides the employer with the proof that the supervisor actually issued the letter of reprimand to the employee. The following is a sample receipt for the written reprimand.
