Offences of theft, for example, based on the old common law offence of larceny, are now governed by the Theft Acts 1968, 1978 etc; and the original penalties for murder (though not the offence itself) were replaced by

England and Wales has a common law legal system, which has been established by the subject matter heard in earlier cases and so is the law created by judges. It originated during the reign of King Henry II (1154-89), when many local customary laws
